We are writing as members of the Wild Olympics Campaign in strong support of the Wild Olympics Wilderness and Wild and Scenic Rivers Act (S. 1510) being considered by your Committee as part of the congressional hearing held on April 21, 2016. Please submit these comments as part of the official hearing record.

The Wild Olympics Campaign is a coalition of ten organizations who have been working since 2008 to protect wild forests, rivers and upper watersheds on the Olympic Peninsula. These watersheds provide local communities with clean water, world class outdoor recreation opportunities and sustain our outstanding Peninsula way of life. They are vital to the health of Hood Canal and Puget Sound and are critical habitat for wildlife, steelhead and salmon. The campaign works with other local citizens and community leaders to establish new Wilderness and Wild and Scenic river designations for these natural treasures.

#### Wild Olympics Legislation

The Wild Olympics legislation as introduced by Senator Patty Murray and Representative Derek Kilmer would designate the first Wilderness on Olympic National Forest in more than 30 years and the first ever Wild and Scenic Rivers on the Olympic Peninsula. Specifically, the legislation would protect 126,661 acres of federal land managed by the Olympic National Forest. It would also designate 19 new Wild and Scenic Rivers plus their tributaries on Olympic National Forest and Olympic National Park.

The legislation would also protect critical fish and wildlife habitat. The remote headwaters on Olympic National Forest are sensitive spawning grounds for salmon, cutthroat, summer steelhead, bull trout and other species. Elk, bear and other wildlife rely on unfragmented, unroaded forests to thrive.

The Wild Olympics bill would help protect the economic future for the Olympic Peninsula. Our streams and waterways support a vibrant fishing and shellfish industry, attract millions of dollars in tourism annually, support a thriving outdoor industry and provide clean drinking water to our residents. They provide the stunning scenery and a high "Quality of Life" that attracts entrepreneurs, new residents and investment in our communities. The legislation has been crafted to protect these economic benefits while, at the same time, having no impact on existing timber jobs in local communities.

The upper and middle watersheds protected by the Wild Olympics legislation provide clean and safe drinking water for local communities and tens of thousands of residents of Port Townsend, Port Angeles and Sequim. Protecting these intact forests ensures that the quality and relatively inexpensive water will continue to be provided from these forested headwaters in the future.

The legislation protects and expands world-class outdoor recreation opportunities like hiking, camping, paddling, climbing, hunting and fishing. Residents and visitors alike spend their money at local businesses on the Olympic Peninsula, eating at local restaurants, finding lodging, stopping for gas and purchasing supplies for their outdoor pursuits. Attractions include Olympic National Park (which ranks fifth in visits of all national parks), the Quinault and Hoh Rainforests, mountain biking the Dungeness – Gold Creek loop trail system, paddling the whitewater of the Dosewallips and Duckabush Rivers and hiking popular trails like Lena Lake and hiking among cathedral old growth forests in the South Fork Skokomish.

These free-flowing rivers and streams are also vital to the long-term health and recovery of Hood Canal and Puget Sound. They provide clean, cold water vital to the Peninsula's Shellfish industry and the hundreds of local residents they employ. Acting to safeguard our healthy watersheds now is far less costly than restoring degraded watersheds later. By granting these natural treasures the permanent protection they lack today, this legislation makes a down payment on the economic future of generations to come.

#### Public Process: Reaching Out to Local Stakeholders Early and Often

The Wild Olympic Campaign's goal has been to develop a conservation plan tailor-made for the diverse local recreation, access and economic needs of the Olympic Peninsula. Our campaign has worked with the offices of Senator Murray, Representative Kilmer and former Congressman Norm Dicks for more than five years to craft a carefully balanced proposal that provides the strongest possible protection for salmon habitat, clean water and recreational opportunities while accommodating concerns and requests from diverse local stakeholders.

Senator Murray and Representative Norm Dicks (and subsequently Representative Kilmer) met with a wide range of local stakeholders on the proposal including timber interests, land management agencies, local Tribes, timber interests, local elected officials, conservation groups, backcountry horsemen, mountain bikers, businesses, shellfish growers, sport and commercial fishermen, community leaders and other local residents.

As a result of listening to local stakeholders early and often, a number of significant adjustments were made to previous proposals resulting in the current balanced legislation that sits before your Committee. For a full accounting of the addressed issues relevant to the Wild Olympics legislation being considered by your Committee see <u>Appendix A</u>.

#### **Strong and Growing Local Support**

The Wild Olympics legislation enjoys strong local support from Washington State residents but most importantly from those who live closest to the proposal on the Olympic Peninsula and the 6<sup>th</sup> Congressional District. A bipartisan poll in 2012 found that nearly two out of three (64 percent) likely voters in the 6<sup>th</sup> Congressional District support the Wild Olympics plan proposed by Rep. Dicks and Sen. Murray. The strong support is a direct result of the extensive public process and balanced approach used to address local issues raised early on in the development of the proposal.

More than 10,000 local residents who live in the counties of the 6<sup>th</sup> Congressional district closest to the proposal have signed a petition supporting the Wild Olympics proposal. These residents of Clallam, Jefferson, Grays Harbor, Mason, Kitsap and western Pierce Counties understand the connection between protecting the wild places that are a significant part of the quality of life they enjoy. The ancient forests, clean water, wildlife and access to recreational opportunities are a major reason of why they choose to live, work and play in this incredible landscape. For a summary of the local individual support for the proposal please see Appendix B.

In all, 550 local stakeholders have endorsed the legislation including local businesses and farms, conservation and recreation organizations, sportsmen organizations, elected officials and religious leaders. A total of **72 local elected officials** have endorsed Wild Olympics including County Commissioners from all four Olympic Peninsula Counties. **More than 30 leading hunting and fishing organizations & local guides** have endorsed, including Washington Council of Trout Unlimited, Northwest Sportfishing Industry Association, Washington Backcountry Hunters and Anglers and local hunting & fishing guides like Northwest Guides & Anglers Association, Piscatorial Pursuits, Waters West Guide Service and Little Stone Flyfisher Guide Service. A total of **17 other outdoor recreation user groups and organizations** have also endorsed the legislation including Washington Trails Association, Evergreen Mountain Bike Association, International Mountain Bicycling Association, Access Fund, Washington Climbers Coalition and Olympic Peninsula Paddlers Club. **More than 300 local businesses** have endorsed the proposal including Taylor Shellfish, Ocean Gold Seafoods, Sage Manufacturing, Intellicheck Mobilisa Inc, Olympic Raft and Kayak, Sound Bikes and Kayak and Pacific Alpine Guides. For a full list of endorsements for the Wild Olympics legislation please see Appendix C.

#### **Economic Impacts**

Senator Murray, Representative Kilmer and former Congressman Dicks worked to ensure that the final legislation will not impact any timber jobs. The Wild Olympics legislation is also carefully designed to protect and grow local and state outdoor recreation industry. Outdoor recreation in Washington State generates \$22.5 billion in annual consumer spending, and supports 226,600 jobs. The Olympic Peninsula, with Olympic National Park and the adjacent Forest Service lands and rivers, is an important piece of Washington's outdoor recreation picture. As a result the legislation enjoys strong support from the Outdoor Industry Association, Conservation Alliance, Outdoor Alliance and more than 40 other local outdoor oriented businesses, outfitters and guides.

Furthermore, permanent protection for public lands helps attract new residents, entrepreneurs and investments that create local jobs that grow the local economy. A November 2012 report by the independent, non-partisan Headwaters Economics Institute entitled "West Is Best: Protected Lands Promote Jobs and Higher Incomes - How Public Lands in the West Create a Competitive Economic Advantage" makes this point well. That report found that protected public lands are key to attracting companies, entrepreneurs and workers and that national parks, national monuments, wilderness areas and other protected public lands in the Western US have enhanced the competitive advantages of high-tech and professional services companies — a major reason why the western economy has outperformed the rest of the U.S. economy in employment, population, and personal income over the last four decades.

The legislation also protects rivers and streams vital to the future of Washington's fishing and shellfish industries. Washington State shellfish growers support jobs for hundreds of area residents and provide an estimated \$270 million economic impact statewide. Taylor Shellfish, based on the Olympic Peninsula, has endorsed the legislation because it would ensure that cold, clean, silt-free water will continue to flow into Puget Sound and nourish their industry.

#### **Recreational Access**

One reason that members of the Wild Olympics Campaign work so hard to protect the wild places on the Olympic Peninsula is so that current and future generations can enjoy them. Preserving and enhancing recreational access has been an important goal for the legislation introduced by Senator Murray and Representative Kilmer.

Local recreational users and other interests have been extensively consulted in the development of the Wild Olympics legislation resulting in a number of accommodations to originally proposed wilderness boundaries in response to local needs. No roads will be closed or affected. No forest service system roads are included within the Proposed Wilderness. This ensures continued access and consistency with the Olympic National Forests' ongoing access and travel management process which makes all decisions related to road maintenance.

Thank you for the opportunity to share our support for the Wild Olympics Wilderness and Wild and Scenic Rivers Act. We appreciate that the Senate Energy and Natural Resources Committee has decided to include this legislation in its recent hearing. We look forward to additional congressional action on this bill in the coming months.

# **APPENDIX A: Wild Olympics Proposal Addressed Issues**

## **Forest Management**

## **West Fork Humptulips Thin Sale Exclusion (Grays Harbor County)**



In response to concerns raised by Grays Harbor County Commissioners and the Forest Service, all cutting units identified in the Olympic National Forest's West Fork Humptulips Thin sale were excluded to ensure that the proposed wilderness designations would not conflict with that activity. While there are a few cutting units within

the quarter mile boundary of the proposed Wild and Scenic River designation for the East Fork Humptulips River, because that river has been determined "eligible" by the Forest Service, it is already being managed as it would after designation with respect to the sale. In summary, the proposal will have no impact on the sale, a conclusion consistent with the Forest Service environmental analysis for this project.

#### **East Fork Humptulips Thin Sale Exclusion (Grays Harbor County)**



In response to concerns raised by local stakeholders and the Olympic National Forest, all proposed thinning units identified in the proposed East Fork Humptulips thin sale were excluded from the Proposed Wilderness to ensure that the proposed wilderness area would not conflict with that activity.

#### **Sitkum Thin Sale Exclusion (Jefferson County)**



In response to concerns raised by local timber interests and the Olympic National Forest, all units identified in the preferred alternative of the Sitkum Thin were excluded from the proposed wilderness designation in the Elke-Reade area and along the South Fork Calawah River

### **Queets Thin Sale Exclusion (County)**



Pursuant to efforts by the Wild Olympics Campaign to exclude previously logged stands which were candidates for future restoration thinning, no units identified in the Olympic National Forest's Queets Vegetation Management Project were within the proposed wilderness designation in the Sams River area.

### **Calawah Thin Sale Exclusion (Clallam County)**



Pursuant to efforts by the Wild Olympics Campaign to exclude previously logged stands which were candidates for future restoration thinning, no units identified in the Olympic National Forest's North Fork Calawah Vegetation Management Project were within the proposed wilderness designation.

## **Upper South Fork Skokomish Vegetation Management Project Exclusion (Mason County)**



Pursuant to efforts by the Wild Olympics Campaign to exclude previously logged stands which were candidates for future restoration thinning, no units identified in the Olympic National Forest's Upper South Fork Skokomish Vegetation Management Project were within the proposed wilderness designation.

#### Salal Permit Area



In response to concerns raised by the Olympic National Forest related to the compatibility of this commercial activity with a wilderness designation, nearly 4,000 acres within designated salal gathering permit areas were excluded from the proposed wilderness. As a result the Big Creek, Walker, Hamma Hamma, Donnie Ahi, Vance Brown and Weatherwax salal permit areas have been excluded from the proposed Wilderness.

#### **Timber Impacts**



In response to concerns over impacts to the Olympic National Forest timber base by local timber interests and the Olympic National Forest, the majority of previously logged parcels that could be reasonably ground-based or helicopter logged have been excluded from the Proposed Wilderness.

#### **Quinault Water Tower**



In response to requests from Quinault municipal water authorities regarding the municipal water tower near the Wright Canyon Road, the structure and existing access to it was excluded from the Proposed Wilderness.

#### **Communication Towers in Grays Harbor County**



In response to concerns raised by Tribes and community leaders in Grays Harbor County, two communication towers (repeater sites) have been excluded from the Proposed Wilderness to ensure that access and maintenance of those facilities will remain unchanged.

#### Tribal and Forest Service Administrative Access to the "Undi" Road



In response to concerns raised by certain Tribes and the Olympic National Forest about ongoing mechanized needs for hunting and fishing access and resource management, the gated Forest Service road #2932 ("Undi Road") was excluded from the wilderness proposal to allow current access to continue.

## **Recreation & Access**

#### **Mountain Bike Use on Olympic National Forest**



The Wild Olympics Campaign spent more than two years meeting with local mountain bike advocates on the Olympic Peninsula and state and national mountain bike advocates to identify key mountain bike opportunities on the Olympic National Forest that may conflict with areas proposed for Wilderness. A number of areas (more than 15,000 acres) were identified that were important and included well-used trails that ultimately were

excluded from the proposed wilderness in order to ensure that those riding opportunities would continue in the future. In many cases, these non wilderness trail corridors would be protected within a proposed Wild and Scenic River designation. These addressed issues resulted in the endorsement of the proposal from the Evergreen Mountain Bike Alliance and the International Mountain Bicycling Association. Mountain bike trails that were **excluded** from the proposed wilderness and would therefore be **unaffected** include:

#### Large Group Use at Lena Lake



Lena Lake and its access trail, located on the east side of the Olympic Peninsula, adjacent to the Brothers Wilderness, is one of the most popular and heavily used trails in the area and often accommodates large party sizes (i.e., 12 or more). Responding to concerns raised by hiking and recreation groups, a narrow trail corridor and the lake were excluded from the wilderness proposal and will continue to be managed as a late successional

reserve consistent with its underlying semi-primitive non-motorized designations. This ensures that historical levels and types of use can continue (especially for groups of educational users such as Boy Scouts, Girl Scouts and school groups).

#### **Large Group Access at Lake Quinault Nature Trails**



In response to concerns about large group use, a 100-ft setback from the Proposed Wilderness was established from the popular Lake Quinault Nature Trail system to ensure that large group use will be unaffected by a Wilderness designation.

### **Bogachiel Trail**



In response to concerns raised about the ability to meet future recreation and education needs near the Bogachiel trailhead by the Olympic National Forest, the trail and surrounding land has been removed from Proposed Wilderness.

#### **Future Trailhead Access**



The Campaign has made a significant effort to ensure that current access to trailheads and open roads will be retained in the current proposal. The current access to all existing trails and primary trailheads within the proposal will be unchanged by the proposal.

## Recreational and Tribal Access to Rugged Ridge



After concerns were raised by certain Tribes, west Peninsula residents and user groups about the need for mechanized access to the Rugged Ridge trailhead, Forest Service Roads #2900-070, 2900-072, 2900-075, 2900-078 were excluded from the wilderness proposal to ensure continued access for these activities.

#### **Future Road Access**



In response to concerns about impacts to future recreational and administrative access on forest roads, all Forest Service system roads were removed from the Proposed Wilderness. About 50 miles of forest service roads that have been slated to be decommissioned due to lack of maintenance dollars, high aquatic risk factors

and lack of recreational access potential have been included in a Potential Wilderness category. This designation would only apply if and when these roads were decommissioned by the Olympic National Forest in the future and ensures consistency with the travel management plans.

#### **Future Road Maintenance**



In response to concerns about future impacts to continued maintenance to roads adjacent to Proposed Wilderness, adequate setbacks were established from the Proposed Wilderness for all Forest Service system roads (ranging from 200-500 ft setbacks).

### **Private Property Setbacks**



In response to concerns by local residents and private landowners, a 200-foot setback (a large tree length) from the Proposed Wilderness was established from private property in the Lake Cushman and Lake Quinault areas to ensure no indirect impacts from a future wilderness designation to their property.

## City of Port Townsend Municipal Watershed Pipeline and Diversion Access



After concerns were raised by the City of Port Townsend about potential impacts of the Proposed Wilderness to their continued access to a pipeline and diversion structure that they use under a Forest Service special use permit to manage their municipal water supply, an adequate setback from the Green Mountain Proposed Wilderness along the pipeline road and the Little Quilcene diversion structure was established to ensure

existing and future maintenance and improvement of those facilities by the City. Additionally, the Wild & Scenic River proposal for the Big Quilcene River was reduced by 1.5 miles to a point 300 ft upstream of the City of Port Townsend's Big Quilcene diversion facility to ensure future, pipeline and facility maintenance.

## **Proposal Implementation**

## Wild & Scenic River Proposed Designations Focused on Public Lands



While Wild and Scenic River designation bans dams and other harmful federally-assisted water projects in the bed or banks of the river, it does not provide direct regulatory authority over zoning or land use activities on private or state lands adjacent to the designated river. However, after feedback from local residents and stakeholders, several stretched of proposed Wild and Scenic Rivers on private lands were removed from the

proposal. We are not proposing Wild and Scenic River designation for any river stretches that flow through private lands if the landowner is opposed to the designation. Proposed rivers reaches that were shortened include:

Middle Fork Satsop West Fork Satsop East Fork Humptulips West Fork Humptulips Big Quilcene Sol Duc Bogachiel South Fork Hoh

Hoh Queets South Fork Calawah

#### Wild & Scenic River Proposed Designations focused on Eligible Rivers



In response to concerns raised by local residents and Olympic National Forest, the proposed Wild and Scenic River designations primarily focus on rivers that have been found eligible by the relevant federal agencies. Of the 26 proposed rivers and tributaries included in the proposal the majority have been found eligible by either Olympic National Forest or Olympic National Park. The few that were not found eligible were either not studied or significant changes have occurred

over the past 25 years from the last assessment (i.e., consolidated federal land ownership, presence of listed species). Under its administrative policies, the Forest Service is obligated to manage rivers found eligible to protect the identified outstandingly remarkable values. In practice this makes the management impact of an eligible river post designation much the same except for the added prohibition of new dam building.

#### Wild & Scenic River Classifications Made Consistent with Existing Land Use Allocations



In response to concerns raised by timber interests and the Olympic National Forest, the Wild Olympic proposal carefully applied classifications (i.e., wild, scenic or recreational) to essentially mimic existing land use allocations and management. For example, a wild classification, which is the only one that carries a direct restriction on timber harvest, was applied on existing Wilderness areas, inventoried roadless areas, Late Successional Reserves over 80 years old or other areas that

already included timber restrictions. Scenic and Recreational classifications were used for river reaches that did not include existing timber restrictions.

## Willing Seller Park/Preserve Additions Dropped from Proposal



In response to feedback from local residents, timber interests and Tribes regarding the perceived impact of the willing seller national park/preserve additions, all 37,000 acres were removed from the proposal before it was introduced into Congress by Senator Murray and Congressman Dicks. In contrast to the original proposal by the conservation community, the legislation introduced in

Congress does not include additions to Olympic National Park.
